Introduction

General Overview

The Common Data Model (CDM) reflects the common agreement on how to collaborate in the context of EESSI system. The delivery package contains the EESSI BUC and SED CDM artefacts. This covers specifications, software and user documentation.

CDM structure and artefacts types

The CDM artefacts are used as templates by institutions when exchanging messages in the EESSI system and are defined through a joint effort by AdHoc Business Experts Groups, and the EESSI Project Team. All the implemented Change Requests are following the Change Management Procedure.

The main categories of artefacts that can be found in CDM are:

- CDM Specifications
- CDM Software
- CDM User Documentation

1.1 CDM Specifications

BUC Specification documents	The purpose of these documents is to construct an external view of the 'EESSI business system' as described in Regulations EC no 883/2004 and 987/2009. The 'EESSI Business System' describes the business and expected business processes without consideration as to which part(s) may be realised by an IT System (i.e. the proposed EESSI IT System).		
Generic Specifications			
EESSI Data Modelling Style and Conventions	The document provides guidance regarding the style and conventions used through the EESSI data modelling process for SED the XSD naming and conventions regarding the stereotypes used in the Logical Model.		
Transpositions Updated Functional Specifications	These are the updated specifications of the generic Transposition Engine, which Member States can take into account when technically implementing transposition in their own National Applications.		
BPMN Model Conventions	This document provides information on the conventions used for EESSI BPMN modelling for generating the transactions.

SEDs	For SEDs both the Conceptual and the Logical Model is provided.
	 The <u>SED Conceptual Model</u> defines the business concepts for the different SED Types (regarding sections, core and sectorial components, structure, and business context). Note that the Conceptual Model has a corresponding Core Components entry in the SED Core Components artefact for each identified Core Component. The sectorial components can only be viewed through the source: "Review Portal Tool" as part of the SEDs.
	The <u>SED Logical Model</u> designates the ensemble of artefacts that the SED Modelling process uses in order to encode SED definitions from Conceptual Model.
	• Note that the Logical Model has a corresponding Data Dictionary entry for each translatable metadata. The correlation is made via the entity's unique id.
SED Core Components	SED Core Components represent a set of reusable building blocks (business components, sections, enumerations, and data types) in the EESSI Data Model which are to be used without any further changes by all SEDs in the same way and which will share the same meaning and format in all sectors.
SED Data Dictionary	The Data Dictionary is an inventory of data elements in the EESSI Data Model and provides information about: unique IDs of each element of the SED, technical names, categories, explanatory notes and labels. All labels and explanatory notes of the elements are translated into 24 European languages.
	Transpositions
Transpositions Matrices	There are two transposition matrices files per BUC (one Excel, one JSON); all files for all BUCs in a sector are grouped together in a zip file.
	These files can be used by nationally built transposition engines either in the provided JSONs or Excels or any other custom formats derived from the formats provided centrally, according to national needs and technical implementation.
	These files document the identified transposition needs, as analysed and agreed with the EESSI Ad-hoc groups, and express to the engine specifically what to do in each case (i.e. in each BUC) where transposition was identified as being needed or useful.

	The release publishes an XSD representation, which implements the venetian blind single file design for the EESSI Common Data Model.
sbdh	XSD files representing the Standard Business Document Header (SBDH), which is a UN\CEFACT standard that enables business applications to exchange documents using a consistent interface.
transactions	The BUC model consists of the Business Use Case Transactions and BPMN model artefacts. The BUC transactions define specific authoring rules for a specific SED transaction, participant role, in the context of a related BUC specification.
	In addition, there are also some System Use Case Transactions and BPMN model artefacts.

BPMN Models	BPMN Model contains the descriptions of the BUC processes as Business Model and Notation – BPMN diagrams (i.e. BUCs presented in process diagrams using BPMN notation).		
BUC Guidelines	 The EESSI Guidelines consist of a package of documents aimed to provide guidance for the clerks on the business process; they using hyperlinks to facilitate navigation of content depending on needs. The BUC guideline package consists of: BUC Guideline Introduction, to describe the BUC Guideline package and its way of working; BUC Sectorial Guidelines, to give relevant information per related sector; BUC Type guidelines, to describe the business process for a BUC Type; BPMN Diagrams, to give a visual overview of the main business process of the relevant BUC Type; SED Guidelines, to describe the use of the SED types from that BUC Type, and give a visual overview of a SED; 		



	• PD Guidelines, to give a short description and include the related form relevant in the sector.
Medical Report	The purpose of the Medical report is to capture in a detailed, structured and standardised form the medical condition of a person, as required for the purposes of social security coordination cases. The medical report is exchanged as an attachment in the H_BUC_08 (Request for) Medical Information (sub) process.
SBD Message Examples	This document provides a use case for implementing and sending messages with a valid standard business document header. It describes some flows and scenarios for a national application implementation and the way the messages are being validated.
Web Forms Multilanguage	Web Forms Multilanguage are part of the <u>SED Data Model</u> and represent <i>.htm</i> representations of the SEDs by displaying the associated translations for the 24 EU languages available within the web forms.
XSD SEDs Multiple Files	The venetian blind multiple files is another XSD representation of the <u>SED Data Model</u> . The integration of this artefact in national applications in not supported by the EESSI Project. They are published only for information purposes.

Implemented solution	The change implies updates to SED F018 where section 2. <i>Insurance</i> and 3. <i>Residence periods</i> are removed (Case Owner fills in these sections into SED F020). There are also updates into SED guideline related to F018.

EESSI-4464	SED F027 to be revised by the AHG FB
Initial Request	SED F027 currently contains several free-text fields, which makes it nearly impossible to process it electronically/automatically. The request consists into changing these free-texts with elements that will help the clerk to fill in the data.
Implemented solution	The change implies updates related to several free text fields to SED F027. The updated free-text fields are consistent with other FB SEDs. There are changes related to fields: 1.2 Claim or reply to claim;
	 4.1 Source of income (specific benefit, from employment or self-employment; from property, valuation of land/property, alimony/maintenance payments) 4.2 The period (from/to) for which the data is required; 4.3 Amount of annual income; 5.1 Identification of the deceased person;
	 5.2 Identification of the children concerned; 5.3 Identification of other persons - another parent/guardian applying on behalf of the orphan/child; 5.4 Place of residence of the orphan/child;

Request	While implementing SED H001, we have identified that the current datatype is String for field 1.1.6.7. "Place of birth" in section 1.1.6. "Notification of change in circumstances" of H001. There is a need to change the data type from string to "EESSIAddressLimitedType", which is used for other fields as Town, Region and Country



Implemented solution	Data model for H001 was updated changing the type of the attribute "1.1.6.7 Place of birth" in H001
BUCs impacted	Not applicable

EESSI-4711	H020 individual note needs to be mandatory
Request	For consistency reasons there is a need to update Claim for reimbursement (SED H020) and the reply (SED H021) which need to mandatory contain information about the individual claims and the person they refer to.
Implemented solution	Data model for H020 and H021 was updated changing the individual note as mandatory.

E ESSI-7727	SED H070 (as Sub-Process) does not allow attachments to be sent
Request	When trying to send a H070 SED with attachments in a P_BUC_05 case, the SED is blocked at the AP with Error Code 'EESSI:ERROR:B:0007' because the transaction XSD does not allow a Manifest Item to be added.
Implemented solution	Transactions related to sub-process H_BUC_07 was updated to allow attachment(s) for H070

Request	There is a need to have changes related to place of work, when there is no fixed address into the state of work.
Implemented solution	This change affects SEDs A001, A002, A003, A007, A008, A009, A010 to section related to place of work. The place of work section is remodelled by moving the element <i>No fixed address in State(s) of work,</i> with possible values <i>Yes/No,</i> on top of the section, and creating separate non-mandatory subsection for the other fields.

EESSI-7171	SED A003: multiple choices incorrect from a business point of view
Request	From a business point of view, the Case Owner should only be able to tick one legal basis in field 11.1. <i>Article of Regulation (EC) No 1408 /71 which applies</i> *; by contrast, in the current actual implementation he may choose several values.
Implemented solution	The change consists in the amendment of SED A003, so the Case Owner can only tick one legal basis (single selection, instead of multiple selection) related to section 11.1 <i>Article of regulation (EC) No 1408/71 which applies</i> *.

Request	According to BUC Specs M_BUC_01 is a bilateral BUC, but diagrams and transactions are defined as a multi-lateral BUC. Related issue: EESSI-2335 - Wrong transactions in M_BUC_01
Implemented solution	Process was updated as bilateral BUC and transactions were corrected accordingly.

Request	For SEDs P11000, P12000, P13000 section <i>Attachments</i> is redundant, and has to be removed.
Implemented solution	Section <i>Attachments</i> for P11000, P12000, P13000 is removed. In this case, the necessary updates also extend to the impacted SED guidelines for P11000, P12000, P13000, where the removal of the <i>Attachment</i> section also needs to be reflected.

EESSI-4707	Change to SED P3000 RO
Initial Request	The requested changes to SED P3000_RO aim to avoid the exposure of potential delicate information, as foreseen by GDPR regulation specifically applicable to only one of the EESSI Participating Countries, namely Romania.
Implemented solution	Section 6.1.2 <i>Invalidity is the result of neoplasia, schizophrenia or AIDS</i> is removed by this request. The rest of the sections are renumbered and there is a change in explanatory notes for section 6.1.3 <i>Invalidity caused by other accident than work accident or by other reason than occupational disease, neoplasia, schizophrenia or AIDS</i> . These changes are also reflected in the guideline related to SED P3000_RO.

EESSI-5410	Issues with Pensions SEDs
Request	This request aims to harmonize the label for the element <i>'endDateEntitlementBenefits'</i> across all three SEDs where it is being used, namely P2000, P2100 and P2200. This implies changing the element label <i>'endDateEntitlementBenefit'</i> used in P2200, thereby preventing the failing of SED P2200.
Implemented solution	The element label ' <i>endDateEntitlementBenefit</i> ', from SED P2200 is corrected to match the others and avoid failings. The element label is replaced with ' <i>endDateEntitlementBenefits</i> '. This change needs to be reflected in the technical name and the translations.

EESSI-5677	CR regarding new wording in SED P3000NL point 4.2.3 by Rapporteur of AHG pensions
Request	There is a need to change the wording inside SED P3000_NL to avoid wrong interpretation, and more specifically to rephrase the entire section 4.2.3 <i>Cohabiting partner blood-relationship</i> .
Implemented solution	The change implies updates to SED P3000_NL, section 4.2.3 <i>Cohabiting partner blood-relationship</i> to label name. There are changes in enumeration type and related translations in Dutch and English for the new text.

EESSI-5895	Further harmonization of enumeration lists for values such as 'Other' or 'Unknown' in P-SEDs
Request	In the Pensions sector, for several SEDs there are some enumeration lists, for which the harmonization has not been performed completely. There are lists in which for value ' <i>Other</i> ' the associate number is not yet = 99, or for the value ' <i>Unknown</i> ' is not yet = 98.



EESSI-5895	Further harmonization of enumeration lists for values such as 'Other' or 'Unknown' in P-SEDs
Implemented solution	The change implies updates to several SEDs (mentioned below) in Pensions sector, related to codes 99 and 98. For the value ' <i>Other</i> ' the associated value is 99 and for the value ' <i>Unknown</i> ' the associated code is 98.

Implemented solution	The change implies updates to SED P5000, making Section 5. <i>Total length of periods of insurance/residence</i> optional. This change ensures that SED P5000 may be used even if there are no periods of insurance or residence.

EESSI-6519	Corrections in P3000_CZ, P3000_FR, P9000
Request	There is a need to align Section 3. <i>Claimant</i> used in SEDs P3000_CZ and P3000_FR, with other SEDs P3000_XX from other countries, making this section not mandatory. Moreover, an alignment is needed between the reply SED P9000 and with the request SED P8000, where the section 3.1 <i>Role of the person concerned</i> should be single select enumeration list.

2.1 CDM v4.3.1 Release publication

EESSI 2021 CDM v4.3.1 Release relevant information is available on the dedicated *Confluence page*, under the EESSI 2021 Release Hotfixes site.

2.2 CDM v4.3.1 Release package

The artefacts distributed through CDM 4.3.1 release consists of a complete package of CDM Software artefacts (XSDs SED multiple files, XSDs SED single files, SBDH 1.2 XSDs files and regenerated CDM transactions files) and also the complete package of Business artefacts part of CDM Specifications and User Documentation.

Important Note!

The CDM v4.3.1 release packages are uploaded for security reasons only in the dedicated folder in *FTP* and can be downloaded by EESSI SPOC and Access Point SPOC designated persons. The EESSI Central Service Desk (<u>EMPL-EESSI-SERVICE-DESK@ec.europa.eu</u>) can provide these persons with the **FTP** access credentials upon request.



3 CDM 4.3.1 Release Package

3.1 Business Artefacts / Specifications/ User Documentation

The CDM v4.3.1 Release provides changes presented in:

- two files including the revised BUC Guidelines documentation for the Admin sector and Horizontal Subprocesses, correcting the information included previously in the documents footer;

- complete the Pension BUC documentation by including the PDs subfolder in the Pension BUC Guidelines and updating several links in the documents;

- a file with Sickness BUC Guidelines updated and sample scenarios including the rules mentioned in the BUC Specifications related to the CR EESSI-6438 and CR EESSI-6381 implementation, and updated also to reflect the CR 4698 complete implementation. Also several links in the documents were updated;

- a file containing AWOD BUC Guidelines sample scenarios related to the CR EESSI-6445 implementation. Also several links in the documents were updated;

- a file containing an updated Data Dictionary in English with 3 explanatory notes for DA018, S091, S116 related to CR EESSI-6381 and CR EESSI-6445 implementation, and updated also to reflect the CR 4698 complete implementation. The missing translations in CDM v4.3.0 were added except for the new Norwegian translations which have not yet been delivered to us until this date;

- a file containing the Web Forms Multilanguage archive updated to reflect the CR 4698 complete implementation and with the new translations except for the new Norwegian translations which have not yet been delivered to us;

- a file containing AWOD-BUC-05 specifications updated with the correct rules regarding attachments;

- a file containing SICKNESS-BUC-08 specifications with updated Section 4.1, Branch 1: H_BUC_08 executed at any time after step 5 (correction of previously mentioned step 8).

Important Note! To maintain consistency of delivery approach and ensure that a complete package is available to users in a manner that also maintains the links included in the documents, the CDM 4.3.1 package includes the complete packages for CDM Specifications and CDM User Documentation not just the artefacts changed as an outcome of the current release.

3.2 CDM Software artefacts

To be noted that System Use Cases (SUC) included previously in the "system sync files" folder have been removed from the common data model (CDM) package following the implementation of the request raised in the Strategic CR *EESSI-9278* Restructuring CDM content.



The CDMv4.3.1 Release provides the entire package of CDM Software artefacts including:

- the entire package of regenerated XSDs SED Multiple files;
- the entire package of XSDs SED Single files including 11 corrected and regenerated XSDs SED Single files in CDM v4.3.1;
- the entire package of regenerated SBDH 1.2 XSDs files adding the missing timestamps in their filenames;
- the entire package of regenerated BUC transactions XSDs files.

Important Notes!

The CDM Software artefacts released with the CDM 4.3.1 are intended to fully replace the CDM Software artefacts package released with the CDM 4.3.0, considering the above-mentioned changes and also the removal of the "system sync files" folder.

Software artefacts for system uses cases included previously under CDM 4.3.0 Software artefacts> system sync files sub-folder, are not part of CDM 4.3.1 and therefore must be ignored.

The System Use Cases (SUC) have been decoupled from the common data model (CDM) package and are available now on a dedicated Confluence page, *EESSI System Use Cases* and also in a dedicated folder in *FTP*.




4 Release scope and implementation

The CDM v4.3.1 is delivered as a patch of the previously released CDM v4.3.0 addressing mainly the issues reported through EESSI-9513, EESSI-9743, EESSI 9659 but also correcting some errors in other CDM 4.3.0 software artefacts and in the BUCs Guidelines and Specifications documentation as detailed below. An updated Data Dictionary and a file containing the updated Web Forms Multilanguage archive are also available, including the missing translations in CDM v4.3.0 except for the new Norwegian translations which have not yet been delivered to us until this date. This patch also partially implements CR 9278 as the System Use Cases (SUC) have been removed and are no longer included in the CDM Software artefacts package.

The entire packages of CDM Software artefacts, CDM User Documentation and CDM Specifications are now delivered with the release of the CDM v4.3.1, to maintain consistency of delivery approach and ensure that a complete CDM package is available to users.
